A Jefferson County Men's Correctional facility (Halfway House) for 250 men has been proposed for 8th Ave. and Quail St., Lakewood. This means dozens of sex offenders* will be your neighbors for decades to come as this is located only blocks away from our neighborhood. Since it is within Lakewood **the city can stop this if we act now**. It will take the entire community so we need YOUR help! We have a short time to act.

What you can do to help:

Attend Lakewood and Jeffco Meetings

- **Tuesday, August 18th at 8 am** - Jeffco Commissioners Meeting at the Taj Mahal (County Government/Judicial building at 100 Jefferson County Pkwy, Golden.) We expect the Commissioners will vote to approve a contract to build the new facility at this meeting. There is a time for public comments at the start of the meeting.
- **Wednesday, September 2nd at 7 pm** - Lakewood Planning Commission Public Hearing at Lakewood Civic Center City Council Chambers 480 S. Allison Pkwy. Both sides will present to the Planning Commission which will vote on approving or denying the correctional facility. The public is also invited to speak. After this meeting there is no appeal except to District Court.

Please, Please, Please send an E-Mail: Lots of written documentation is critical and each letter will be reviewed by the Planning Commission. Email often between today and **August 24th**.

"TELL JEFFCO NO" in the subject line and then say--

"I strongly oppose the Intervention Correctional Center Services (ICCS) facility proposed at 11100 W 8th Ave. I urge the Lakewood Planning Commission to vote NO on the Special Use Permit request".
